### The school will do its best to:

- Provide an environment which has been risk assessed in response to the COVID-19 infection and Local Authority Risk Assessment;
- Adhere to the social distancing rules as set out by the government, as much as we reasonably can;
- Provide a curriculum that meets the needs of each child's well-being, mental health and academic needs;
- Contact parents/carers immediately if their child displays symptoms of COVID-19;
- Inform parents/carers if staff or children in your child's 'bubble' test positive for COVID-19, as required by Track and Trace guidelines.
- Continue our clear and consistent approach to expectations, as outlined in this agreement;
- Communicate between home and school through notices, newsletters, ParentMail and the school website.

### To help my child at school, I know and understand that:

- If my child, or anyone in my household, shows symptoms of COVID-19, I will contact school as soon as possible to inform them and follow Track and Trace guidelines.
- If my child shows symptoms of COVID-19 at school, I will collect my child from school immediately. I will get them tested and I will let the school know the result, as soon as possible.
- I understand that it is the preference that children walk or cycle to school wherever this is practicable.
- If travelling by car in order to drop off or pick up my child, I will park away from Weathercock Lane and Burrows Close. I will encourage my child to walk between school and my vehicle.
- If accompanying my child to school, I understand that the preference is for this to be one adult only; I will adhere to the current social distancing rules and wear a face covering at the pupil gate.
- When dropping off and picking up, I will strictly adhere to the timings of the school day (from 8:30 in the morning and from 15:15 in the afternoon).
- My child will not bring any unnecessary items into school with them or take items home from school.
- I will not be permitted to enter the school site, other than to collect my child if unwell. Any appointments must be via telephone, email or MS Teams.
- I will support staff in their efforts to create 'as safe as possible' an environment.
- I will read all ParentMail and other correspondence, responding where required.
- I will inform the school of any changes to emergency contact details.
- If my child's behaviour is deemed unsafe, they might be removed from their 'bubble', on a temporary or permanent basis. If this behaviour persists the Headteacher will consider a fixed term exclusion.

### I will do my best to:

- Follow the expectations that keep me safe.
- Use hand sanitiser when instructed by an adult, unless I have a medical reason not to use it.
- Tell an adult if I feel unwell.
- Not bring things, except my lunch box and water bottle into school from home, or take things home from school.
- Only use my own equipment, e.g. pens and colouring pencils.
- Where possible, keep a one-metre plus distance from other children and a two-metre distance from all the adult(s) in school; keep with my bubble and only my bubble.
- Only enter and exit the school building from the gate and door for my bubble.
- Follow the catch it-bin it-kill it rules, by coughing and sneezing into my elbow or tissue, putting tissues in a bag that I will keep on my desk and put in the bin at the end of the day.
- Regularly wash my hands using soap and water for 20 seconds, or use hand sanitiser, when instructed to do and when I visit the toilet.
- Wear a face covering when inside the school building and when moving from your bubble box.
- Follow the expectations at all times to maintain the safety of myself and others.
- Follow these expectations and know that if I don't, I may be removed from my bubble. If I continue to be unsafe, Mrs Clancy will consider a fixed-term exclusion.
